SHORELINE POLLUTION CRISIS MANAGEMENT - IMO level 3 -

AIMS

The primary aim of this course is to teach participants about the risks and issues relating to shoreline pollution, existing spill response resources, the distribution, missions and responsibilities of the various departments and agencies, funding solutions for response actions, disputes and legal follow-up, and finally crisis communication.

The secondary aim is to promote exchanges between participants so that they can learn about each other's roles and responsibilities.

By the end of the course, participants will be able to join a crisis command centre and contribute to contingency planning for aspects relating to response on the shoreline.

TARGET AUDIENCE

Fire-fighters and rescue services

Personnel working for administrations and local governments who are liable to be in charge of a command centre or play a role in the event of shoreline pollution

TOPICS COVERED

- The response organisation: general framework for response, the French crisis management system;
- Useful data and information: behaviour of oils spilled at sea, prediction tools;
- Response strategies and techniques: resource mobilisation, shoreline protection, involvement of sea professionals, clean-up organisation;
- Environmental impact monitoring;
- Legal and financial aspects: compensation funds, crisis financing, call for tenders procedure;
- Crisis communication;
- Feedback from recent oil spills.

The session is concluded with a tutorial.
